General Rules

(EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.)

USEF MEMBERSHIP STATEMENT Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, **Eventing** Competitions, Dressage Competitions, Competitions and Combined Driving Competitions upon payment of a \$45 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

ENTRIES CLOSE AND MUST BE POSTMARKED NO LATER THAN July 10, 2019, and avoid post entry fees.

UNITED STATES EQUESTRIAN FEDERATION RULES do not require the inclusion of full judging specifications in prize list and programs of approved shows, except classes not listed in the USEF Rule Book.

ENTRIES MUST BE IN WRITING AND: signed by the Trainer (if you do your own training, you must sign) as well as the owner and the ride/ driver/ handler. No entries will be accepted over the telephone. *All* entries must be accompanied by the TOTAL ENTRY FEES, TOTAL STALL FEES, AND USEF FEES, payable in US dollars. All open checks on file in the show office will be closed and deposited at the end of the show.

There will be a \$50.00 fee charged in addition to any bank charges on all returned checks. Checks returned for any reason must be replaced by Cash, Cashiers Check or Money Order. No one will be allowed to show if a bad check or handling fee is outstanding. An Exhibitor will be notified of the returned check and if not settled within 10 days will be turned over to USEF for settlement. Show Management reserves the right to not accept personal checks from any exhibitor who has had a check returned to the show by the bank. Cash, Cashiers Check or Money Orders only will be accepted from those exhibitors. Personal checks will not be cashed at the show office or Canadian money exchanged for US Money.

POST ENTRY FEES: Post entry fees will be accepted for entries POSTMARKED AFTER the closing date of July, 2019, until one (1) hour before the session in which the class is to be held and requires the signature of exhibitor, agent or trainer. Post entry FEE is \$7.00 additional fee per class for regular classes and \$10.00 additional fee per

class for Championship classes. NO POST ENTRY FEE FOR AMHA MEDAL CLASSES OR LEADLINE. **Post Entries for dressage classes** will only be accepted as scratches and availability allow. The show management reserves the right to reject any entry, as well as cancel or combine classes as necessary.

APPEAL PROCEDURE FOR EMERGENCY POST ENTRY: In extreme circumstances, and upon payment of a \$50.00 fee, in addition to regular entry and post entry, a late entry will be accepted into a class after the one (1) hour deadline has passed.

CHANGE IN ENTRIES: Where exhibitors, trainers or stables wish to make a change in entries in any class, they are required to follow the procedure of scratching the existing entry and making a new entry with the Show Secretary's Office. Such changes shall be treated as post entries and charged the post entry fee. In the event of injury to a horse (Veterinarian's Certificate is required); exhibitors may post enter another horse in the same classes at the rate of \$7.00 additional per class.

PURSE MONEY and AWARDS: Purse money will be mailed approximately 30 days following the show and be divided as follows: For the Championships/Stakes, the 1st place winner will receive 100% of that prize money (Winner Take All). Trophy and ribbons will be awarded to sixth place except for Junior Exhibitor which will be awarded to 8th place. **Championship Classes** will be awarded ribbons to sixth place.

FAILURE TO SHOW AN ENTRY: will constitute a forfeiture of entry fees, except with a Veterinary Certificate which must be filed with the Show Secretary prior to the first class in which the horse is not shown unless excused by the Show Veterinarian. A \$25 Office Charge will be made on all cancellations of entries. NO REFUND ON STALLS WILL BE MADE UNLESS THE SHOW SECRETARY IS NOTIFIED 10 DAYS PRIOR TO THE BEGINNING OF THE SHOW including classes cancelled due to severe weather or other emergency. See USEF GR832 and USEF GR912. Refunds will be mailed approximately 30 days following the close of the show.

The show management may cancel classes which have not filled (at least 3 entries). If an Equitation or In-Hand class does not fill, it may be combined with the next older age group and exhibitors will be notified.

This show will use the one-judge system. The Judge's decision in all classes will be final.

Cross entry from Morgan Classic Pleasure to Morgan English Pleasure and Morgan Pleasure Driving is permitted provided shoeing requirements are met.

HEADGEAR. Riders must wear **ASTM/SEI** approved headgear with properly fitting harness in the following: All classes where jumping is required and when jumping anywhere on the show grounds. (exception: Trail classes). Hunter Seat Equitation Classes, Dressage riders when warming up for and riding in Dressage classes (exception: Western Dressage). Leadline Riders at all times when mounted. Protective headgear is acceptable in any other division or class without penalty by the judge. See GR801.

HEALTH REQUIREMENTS Coggins: ALL horses must be accompanied by a record of a negative official test for Equine Infectious Anemia conducted within 30 days.

GATE HOLD: must be requested prior to the start of a performance. It will be granted only when horse/rider are in consecutive classes and shall not exceed 3 minutes

SHOW OFFICE: will open at 12:00pm Wed, July 31st. The telephone number to the show office is (360) 805-6711. There will be a \$25 Office charge per owner. This fee includes ONE program. Additional programs may be purchased in the show office.

THE EMERGENCY VETERINARIAN'S name and phone number for the show will be posted on the Show Office door.

CAMPER HOOKUP: \$30.00/35.00 per night. There are 87 camper hookups available on a first PAID first served basis. Trucks, campers, etc. parked in hookup spots but not hooked up will still be charged the hookup fee of \$30 per night. Please pick up your camper permit at the show office. Showers available.

STABLING POLICY: There are 312 10x10 permanent stalls with a five foot wide front sliding door. ALL STALLS are \$120 each. Bedding: In lieu of having to purchase individual baled shavings, the show will be providing bulk shavings at the cost of \$50 per horse stall & includes disposal. Shavings will be available in 2 locations on the fairgrounds. We ask that you use discretion when bedding your horse stalls throughout the 4 days of the show, in the event the bulk shavings run out, baled shavings will be available for purchase (price to be determined at show).

Those wishing to be stabled together MUST FILL OUT THE STABLING REQUEST ON THE ENTRY FORM, AND GET THE ENTRIES IN EARLY AND TOGETHER. Stalls must be paid as a whole. Trainers splitting the cost of tack stalls, etc. with their clients must make these arrangements personally and not through the Show Office. Stabling will be available from 8:00am Tuesday July, 30, 2019 to 9:00pm Sunday, August 4, 2019. ABSOLUTELY NO HORSES WILL BE ALLOWED ON SITE PRIOR TO TUESDAY, July 29, 2019 AT 8:00am. Set ups are allowed to begin after 5:00pm Monday July 38, 2019. Please notify the Show Secretary ahead of time if you will need stabling either before or after these dates. Early or late stabling will be charged at \$30.00 per night, payable to the C-Fair Charity Show. A check must accompany the request or the stalls will not be reserved. Dressage Stabling will be available from 8:00am Wednesday, July 30, 2019 to 8:00pm Thursday, August 1, 2019. The stabling fee will be \$40.00 payable with entry. These stalls are located on the outside of barn 105. The stall chart will be posted on the guard booth at the entrance of the facility. Stall assignments are determined by the years of participation and financial support. Stall fees must accompany all entries. Please indicate by name, on stall request, if you wish to be stabled near someone.

HAUL IN: Fee of \$25.00 per day, per horse will be charged for those showing out of their trailers. Horses may not stay in trailers overnight and must be attended at all times. Please check in at the Show Office.

YOUTH OF THE YEAR CONTEST – DETAILS/SCHEDULE WILL BE AVAILABLE AT SHOW OFFICE ON July 31st.

United States Equestrian Federation rules do not require the inclusion of full judging specification in prize list and programs of approved shows, except classes not listed in the USEF rule book.

RULES AND REGULATIONS EVERGREEN STATE FAIRGROUNDS PO BOX 129 MONROE, WA 98272 (360) 805-6700

To ensure a smooth and successful show, all exhibitors are asked to read and adhere to the following rules. Blatant disrespect of the rules may constitute grounds for elimination.

NO SMOKING IN THE ARENA OR BARNS

PARKING AREA: BY ORDER OF THE FIRE MARSHALL; Vehicles may not be parked within 100 feet of the barns. Vehicles in the barn area must be loading or unloading only.

BARNS: The fairgrounds will no longer allow stall front/panel removal, under no circumstances is one permitted to disassemble any of the stalls or parts of the barn. To do so will jeopardize further use of the facilities.

OUTSIDE BARN DECORATIONS: Request to display decorations outside the barns should be submitted to the Evergreen State Fairground, one month prior to set up.

BLOCKING OF BARN EXITS & AISLES: (BY ORDER OF FIRE MARSHALL) Decorations, signage or temporary structures may not cover or block any building exit aisle way or cover any fire extinguishers, fire hoses, phones or electrical panels.

NO! SCOOTERS, SKATEBOARDS, BICYCLES, ROLLER BLADES, MOTORIZED CARTS AND MOTORBIKES. (From Snohomish County Risk Management Office) These vehicles are not allowed on the fairgrounds and will be confiscated until end of show.

DOGS ABSOLUTELY No Dogs allowed in the Equestrian Park. This includes BARNS, ARENAS and WORK-OUT AREAS. (Exception: Assistant dogs, seeing-eye dogs, dogs for the hearing impaired, etc.) Dogs that are brought to the fairgrounds MUST BE KEPT SECURED TO THE PARTICIPANT'S RV OR TRAILER in the outside parking areas only. Owners are required to clean up after their dogs. Dogs that cause disruptions must be removed from the fairgrounds. Promoters, show officials and fairground gate attendants and personnel have the authority to enforce this requirement.

ARENA FOOTING Outdoor Warm Up arena - Sand. Indoor Competition Arena - Dirt. Arena size 178'x 300'

GR845 Equine Vaccination Rule 1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian. the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds.

The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. BOD 1/17/15 Effective 12/1/15.

MORGAN ELIGIBILITY: Please be aware of the approved rule changes to MO101 that were inadvertently omitted from the 2016 Rule Book effective 12/1/15. Horses shown in this division must be registered with the American Morgan Horse Association, Inc., or an organization having registry reciprocity (Canadian Morgan Horse Association, British Morgan Horse Society, Swedish Morgan Horse Society). Horses must be entered under their full registered name or if under one year of age be eligible for registration. Horses must be entered under the names of the owner(s) or lessee of record with AMHA, CMHA, or BMHS. A copy of the registration papers showing recorded ownership or proof of lease must be submitted with entry form at the time of making entry. Competition management is responsible for notifying exhibitors of this requirement. Owners (lessees), exhibitors, and trainers of horses participating at Federation licensed competitions in all Morgan sections must be current members in good standing with the American Morgan Horse Association, Inc., or an organization having registry reciprocity (or pay a non-member fee. Set fees shall be payable to AMHA.) An original or a copy of the membership card must be provided to the competition unless the competition, at their discretion, confirms membership electronically with one of these organizations. Lessees are considered owners in connection with this membership requirement. In the event of an entry under multiple ownerships, only one owner need be a member. Exceptions: Exhibitors in Leadline and/or Walk-Trot classes are exempt from this membership requirement. Additionally, a parent/guardian when only signing an

entry blank for a minor is not required to be a member or pay a non-member fee

AMATEUR NON MEMBER: Amateur cards are no longer available for non-members. Only active Federation members may obtain amateur certification. Every person who has reached his/her 18th birthday and competes in classes for amateurs under Federation rules must possess current amateur certification issued by the Federation. (Exception: This is not required for Opportunity classes except Dressage) Please make sure these requirements are met for classes restricted to Amateur riders (GR1307)

STALL AWARDS: The judging for stall awards will be done on Saturday morning. The awards will be announced during the early part of the Saturday afternoon performance. There will be two awards: 4 horses and under, 5 horses and over. Judging will use the following criteria: Stable name/banner identification; Name plaque for each horse (on stall or displayed somewhere); Halter and lead by each stall door; Appropriately decorated stall presentation; Emphasis on usefulness/workability as well as display. Exhibitors are reminded that all stall decoration material must be fire proofed or fire retardant and must permit safe and free passage of exhibitors and their horses in all areas on the grounds at all times.



ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

MOTORIZED VEHICLE STATEMENT: In accordance with USEF GR1301.7: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages. claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. PLEASE ALSO REFER TO THE EQUESTRIAN PARK RULES AND REGULATIONS IN REGARDS TO OPERATION OF



What you will need - Come prepared and have a fast, pleasant experience ©

1. A Negative Equine Infectious Anemia(EIA)Certificate

Also known as "Coggins." Have an accredited veterinarian take a blood sample and send it to a labfor tests. When the tests are negative, a Coggins (or EIA)certificate will be returned. The document must be completed and signed by your veterinarian and endorsed by a Canadian Food Inspection Agency (CFIA) or a United States Department of Agriculture (USDA) veterinarian. Talk to your vet about the time frame needed for this process. The Coggins certificate is valid for 6 months (180days) from the date that the blood sample was taken.

2. Health Certificate

The veterinarian will examine your horse, in conjunction with taking the bloods ample. The Coggins test must be negative before a Health Certificate will be issued. This certificate must be signed by both your vet and a CFIA or USDA veterinarian. The Health Certificate is valid for 30 days from the date of issue. You can take your horse across the border as many times as you like within that 30 days.

3. A Supplementary Declaration or Certification sheet

In order to help control the outbreak and spread of CEM, this new supplementary declaration will be attached to your Health papers. Part A is for those travelling across the border for exhibition purpose-training, showing, rodeos, etc. Part B is for those travelling across the border for breeding purposes. This form is provided by CFIA when the Federal Vet approves the Health Certificate. A new supplement is required each time you cross from Canada into the U.S., so ask for as many supplements as you're going to need, or make copies. The USDA does not provide this Supplementary sheet as their Health Certificates include a statement regarding CEM.

4. Copies of each certificate.

Most ports of entry require a copy of all or some of these documents. The customs officers at theborder may or may not be willing to make photocopies of the documents, and also a fee could be levied. Better to be prepared and take copies with you. Always keep the original.

Stop at both the Canadian Customs Office as well ast he U.S. Customs Office. Have the Customs Officers stamp the "date of exit" on the Supplementary Declaration. Some U.S. border agencies do not recognize this form and although there is a spot for them to stamp (either/or), they may not and will send you back to the Canadian Customs Office. This protocol is not consistent, so cover all your bases and stop at both.

Show the Customs Officers the Health and Coggins Certificates and provide copies for those that need them. Requirements can vary from one Customs Office or port of entry to the next, so be prepared.

Upon the horse's return to Canada or the U.S., stop at both Canadian and U.S. Customs Offices again. When you return to Canada or the U.S. within 30 days of the date of entry into either country, no veterinary inspection is required at the border. Horses may enter/re-enter at any port of entry.

Have the Supplementary Declaration stamped again at the Canadian Customs Office . You will be required to sign the declaration stating that the horse was not bred (Part A) and travelled only to the "address of destination" as stated on the Health Certificate. If you bred your horse you will need a USDA accredited veterinarian's signature on the form (Part B) and also that of a USDA vet at the border upon return to Canada.

Except as may otherwise be mandated by local law, protective headgear is strongly recommended for everyone showing in any class in the Roadster Division as outlined in GR801.4, .7 and .8. Except as may otherwise be mandated by local law, while riding or driving anywhere on the competition grounds, all juniors riding or driving in Roadster to Bike or Roadster Under Saddle classes must wear properly fitting protective headgear which passes or surpasses ASTM (American Society for Testing and Materials)/ SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag as specified in GR801. Harness must be secured and properly fitted. A matching cover may be worn over the protective headgear or the protective headgear may be painted in matching stable colors. See USEF RD101 through RD113 for full specifications.

Any Friesian bred horse regardless of color, height and/or registry that can prove its Friesian heritage and identity is eligible to compete provided that the horse and the horse's owner/lessee are IFSHA members in good standing, and the horse has been issued an IFSHA membership certificate or application applied for through the competition office. Horses and/or horse owners/lessees can make application for membership to IFSHA at a USEF licensed competition provided that the following items are given to the competition secretary prior to the release of the competition number. (1) IFSHA Membership application or membership card for horse owner/lessee (2) IFSHA Membership application for horse (3) Payment in full (4) Proof of Friesian Heritage, which shall include a copy of the horse's breed registry registration certificate. (5) Proof of Permanent Identification (IFSHA Equine Identity Record form must be completed if proof of identification does not appear on the horse's breed registration certificate). See FR101.3.

Individuals signing the USEF Entry Agreement (i.e. rider, driver, handler, agent of an owner, and trainer) for horses competing in the Friesian division must be members of IFSHA or pay to IFSHA a non-member fee for each competition in which competing. Horse owners/lessees must be members of IFSHA as required in FR101.1a. Exception: When a parent/guardian is signing for a minor, they do not have to be IFSHA members or pay the IFSHA non-member fee. IFSHA membership forms for horse and horse owner/lessee can be located on the IFSHA web site at www.friesianshowhorse.com under "Join IFSHA." A horse's Equine Identity Record form can be found in the IFSHA "Forms Library" section. IFSHA is responsible for notifying USEF if an IFSHA membership application for horse and/or owner taken at the competition is not in compliance. All horses must have a permanent identification mechanism. Acceptable forms of identification are freeze marks, tattoos, brands, tongue codes or RFID microchips that can be verified back to the horses breed registry certificate, or a certification of administration by a licensed doctor of veterinary medicine. IFSHA and its assigns reserve the right to validate identification of a horse at any time, inclusive of DNA verification by mane or tail hair sampling. All horses must be registered with a foreign or domestic registry that maintains proof of Friesian heritage through DNA testing and record maintenance. IFSHA and its' assigns reserve the right to validate the horse DNA at the horse owner's expense in the event that a protest or grievance has been filed with IFSHA and/or the USEF. Part-Bred Friesians must have at least 50% pure Friesian blood and one pure blood Friesian parent (exception: horses that have competed in any Friesian and Part-bred Friesian Division class at a Federation licensed competition prior to January 1, 2006.) The following information is a general summary of descriptions and guidance's that are not all inclusive of the rules and regulations that govern each class. For complete information on each class please refer to the current USEF Handbook, or www.usef.org under Sub-Chapters FR-1 through FR-28. (Notice to USEF Horse of the Year Participants: Points are based on the number of entries in the class. See USEF GR1129 – GR1129.7, & GR1113.2b. (Notice to IFSHA Horse of the Year Participants: IFSHA will reward full points regardless of number of class entries. The Friesian and Part-Bred Friesian that receives the most points during the show will each be awarded a High Point Award. In the event of a tie, consideration will be made on the quantity of Friesian or Part-Bred Friesian Championship and/or Reserve Championship awards received during the show. Bridle shall be light, show type; either snaffle, double (full) or pelham. Kimberwicke bit is permitted. Browbands and cavesson other than dressage types are prohibited. Unconventional tack such as figure eight, drop, or flash nosebands are not permitted. English saddle of any type is required. Girths of either leather, white web, nylon string or suitable material. Martingales, breastplates not allowed. Acceptable Hack attire is required. It consists of conservatively colored coat, breeches and boots. A conservatively colored hunting cap or derby is required. Formal attire consisting of white breeches, top hat and tails may be worn. Spurs, whip or crop optional at the exhibitor's discretion.

GAITS: WALK - a four beat gait: Straight, true and flat-footed. TROT - a two-beat gait: Free-moving, straight, rider maintaining light contact with the horse's mouth at all times. CANTER - A three-beat gait: Straight on both leads, smooth. Normal, collected and extended gaits to be called for both ways of the ring. Rider will post the normal trot, sit the collected trot and post the extended trot. Refer to USEF NS148-NS151. At the discretion of the judge, horses while on the rail may be asked to halt and rein back. Horses shall be able to perform all of these gaits with a noticeable transition between the normal, collected and extended gaits. Horses must appear to be under complete control and easily ridden. Obedience is of prime importance. To be judged on performance, manners, quality and conformation. NOT USEF.

RANCH HORSE DIVISION – OPEN TO ALL BREEDS

- The purpose of Ranch Pleasure should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse working outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward, working speed while under control of the rider. Light contact should be rewarded and the horse shall not be shown on a full drape of reins. The overall manners and responsiveness of the horse while performing the maneuver requirements and the horse's quality of movement are the primary considerations.
- Horses should NOT perform or be rewarded for performing gaits as they do in Western Pleasure. The horses are to be presented in a more forward-moving style than the typical Western Pleasure horse. The hose and rider will be scored on movement, which is cadence and rhythm of gaits, smoothness and consistency in performance, along with how they perform on the optional maneuvers.
- For rules regarding correct Western appointments, refer to MO132
- The required gait maneuvers will include the walk, jog, and lope of both directions; and the extended jog and extended lope going at least one direction; as well as stops, and a back.
- Optional maneuvers are side pass, turns of 360 degrees or more, change of lead (simple or flying), walk, jog or lope over a pole(s); or some combination of maneuvers that would be reasonable for a ranch horse to perform.
- RANCH RIDING: Each horse will work individually, performing both required and optional maneuvers, and scored on the basis of 0 to 100, with 70 denoting an average performance.
- RANCH PLEASURE: Horses will work as a group on the rail and will be asked to perform the required maneuvers only.
- The overall cadence and performance of the gaits should be free-flowing and ground covering at all gaits, with an emphasis on forward movement. Transitions should be performed where designated, with smoothness and responsiveness

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are
 also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of
 horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan [®]/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Education Membership (EM): A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF

postcompetition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan VUSDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan VUSDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Exceptions to USDF Membership, Non-Member Fee, and Horse Registration Requirements

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of 125 independent organizations throughout the United States with a membership in

excess of 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which

the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership

with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine

whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit.

Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is

no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse

is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international

competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life. While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to

ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication,

the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a

longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program

of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training. United States Dressage Federation

Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
